First Annual Town to Town Tour: a huge success

When the snow covers our mountain towns in winter white, the chairlifts are filled, and everyone is talking about new ski gear, it gets a bit tougher.

So we got an idea—a celebration of winter on the Rio Grande Trail, which links our communities all year long. This fun, family-oriented cross-country event is a great way to remind everyone that **RFOV** supports our trails year-round. The inaugural Town to Town Tour was a huge success, with over 320 participants and 42 volunteers. We were blown away by the interest and support **RFOV** received for this event.

Skiers and a few snowshoers of all ability levels toured the 14.8-mile course under a clear blue sky – about half starting from Stein Park in Aspen and the other half from Woody Creek. We met in Basalt for a spirited celebration at the Roaring Fork Club River Cabin.

Smiles were to be had by all, as the sky was clear and sunny until mid-afternoon when the wind picked up and temperatures dropped. A warm outdoor fire, beverages, food, and some great giveaways welcomed the crowd.

PRESERVING THE CROWN

One question I get a lot from folks is “David, what to you do in the winter time?” My usual response is that I write grants, start planning the next year’s project season, and enjoy a little bit of slow time over the holidays. But not this year!

In addition to putting on the new Town to Town Tour this winter, **RFOV** facilitated the development of a citizen’s alternative plan for the future management of the local area known as the Crown. This distinct 9,103-acre parcel southeast of Carbondale is administered by the Bureau of Land Management, and is currently open to all users. As the population of the mid-valley has increased dramatically, so has recreational use of The Crown.

With the BLM starting to update the resource management plan for our area—a process occurring only once every 20 years—the opportunity came up to look at the future of The Crown. Due to current impacts and the projected increase in use of this close-by area, the BLM wanted to see if the community would support creating a Special Recreation Management Area (SRMA) that would encompass The Crown. The only other local SRMA is Red Hill/Mushroom Rock.

Our contacts at the BLM suggested **RFOV** convene a series of public

input, that was the primary motivation for **RFOV** to host these meetings—the chance to act as a catalyst for a group of citizens to become active stewards of this public land.

The meetings were very successful, drawing good numbers of participants from a broad cross-section of interests. We estimate more than 100 people attended at least one of the meetings, including ranchers with grazing rights, representatives from the Colorado Division of Wildlife,

neighboring property owners, and the full range of users (motorized, cyclists, equestrians, hikers, and hunters). I have to say that the overwhelming unifying factor of this disparate group was the desire and goal to preserve The Crown. All were concerned that the human pressures on the Crown were already significant, and

In the end, every group made compromises, yet all agreed to the citizen's alternative plan. And, the second achievement was the significant number of meeting participants who signed up for the ongoing effort. I expect the BLM will adopt the citizens' plan in general and I look forward to helping with future related efforts and projects. My thanks to all the participants for stepping up and getting involved, and for demonstrating how real public dialogue can benefit our public lands!

MAPPING THE FUTURE

New strategic plan keeps our mission fresh, growing

RFOV enters its 14th project season in 2008. One reason our organization has grown to be so successful is that we've been very purposeful in setting goals and having a plan to achieve them. **RFOV's** evolution continues as we prepare to finalize and adopt our third revised Strategic Plan to guide us over the next three to five years.

The key question: "What can and should **RFOV** do to increase the number of volunteers and engage more of our community in the stewardship of our trails and public lands?" The discussion began with two very enlightening focus group sessions in the summer of 2006. Their purpose was to gauge the public's perception of **RFOV** and our value to the community. We invited several distinguished people from the community who for the most part did not have an existing relationship with **RFOV**. We learned two significant things:

- There is little public knowledge of how or by whom our trails are maintained, or even that it ever needs to be done. This is also true for other types of conservation projects **RFOV** does, like Tamarisk removal or riparian restoration plantings.
- The public is unaware of the distinctions between the numerous but varied conservation non-profits in our area.

After learning a bit more about **RFOV**, our work, and the numbers of volunteers we've engaged, both focus groups thought **RFOV** has an opportunity to build on our success. This is predicated on our doing a better job of connecting with all those who love and use our trails,

informing the public about what we do, and generally raising our profile in the community. If more people are aware of **RFOV** and our work, we will generate enough support to build on or add new volunteer programs.

We've already made some significant strides in raising our profile: the successful new Town to Town Tour winter event, hosting the recent public meetings on The Crown, the new tagline "We Do Trails Together," and working harder to explain what we do. We are also working on providing more informative signage at existing trailheads.

Our Board of Directors, with help and input from **RFOV's** committees and Crew Leader Corps (more than 100 individuals all told), has honed a list of eight different ideas to further pursue our mission. In no particular order:

- **Increase the number of Adopt-a-Trail groups**—find more groups in the area that may be interested and able to adopt a trail: businesses, service organizations, churches, homeowner associations, etc.
- **Build a Youth program**—get the kids (and their parents) involved in volunteer conservation projects.
- **Increase education**—develop programs to provide more education on associated stewardship values (in addition to a Youth Program)
- **More and/or larger projects**—we need a larger number of volunteers in order to make more of an impact.
- **Advertising**—increase advertising to raise awareness of **RFOV**, our work, and our mission to increase volunteer numbers and community support.

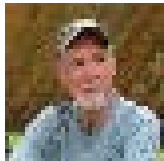

The Food Sponsor of the Year Award went to Melinda Ness of Basalt for personally catering a project at Wulfsohn Mountain Park in Glenwood Springs despite cold, rainy weather. - **Make user contacts on trails and at trailheads**—connect with our prime constituency – trail users.
- **Hire a part-time or full-time seasonal trail person**—a person with “Instructor Level” skills to work with Adopt-A-Trail groups, youth groups, and on **RFOV** field work.
- **Consider one or more fundraising activities** that would complement

RFOV’s stewardship mission and values.

Which ideas do you think would be most effective? Maybe you’d like to help us implement one of these ideas? Please let us know. Our hope is to have our new Strategic Plan completed this spring. We’ll keep you posted!

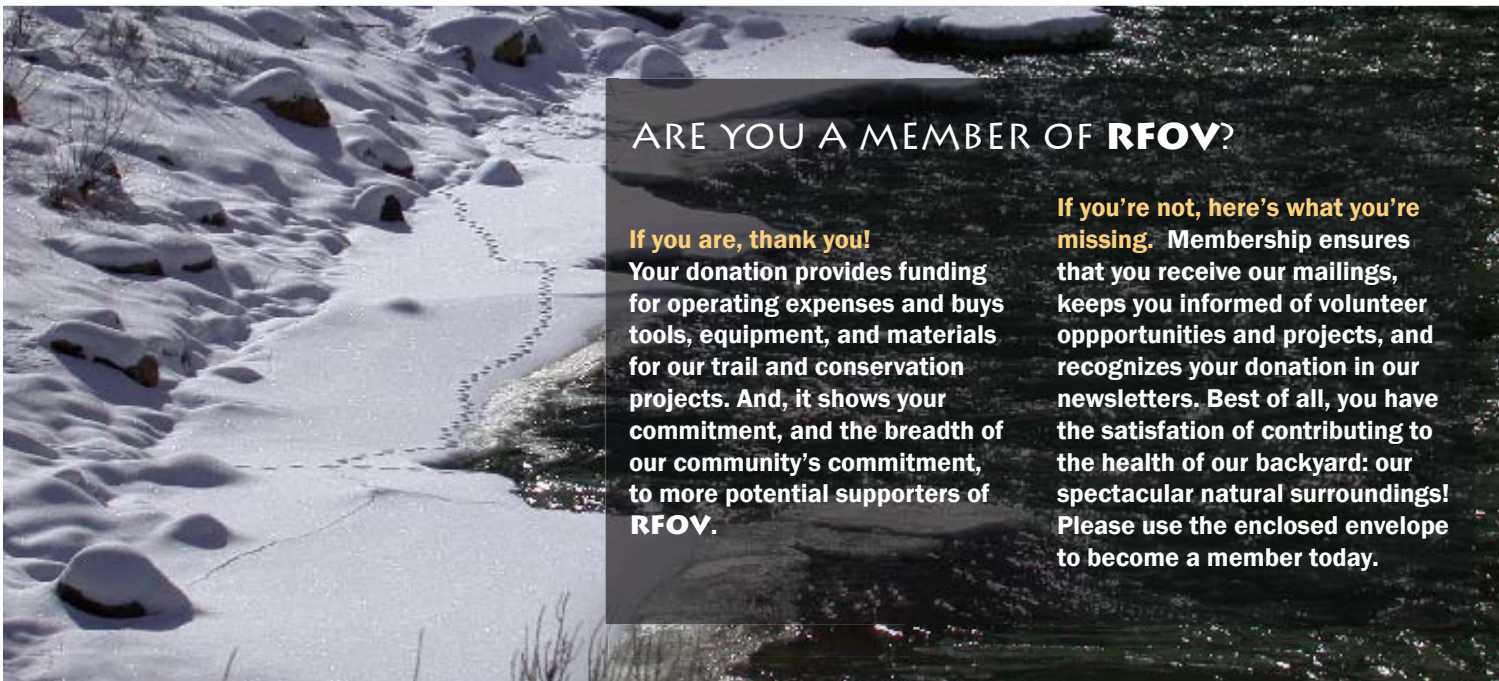
